The latest study on Ease of Doing Business (EoDB) issued by the World Bank Group shows Indonesia's ranking declining from 72 to 73 last year. This situation requires special attention for improvement in the future in order to achieve the targeted ranking of 40 announced by President Joko Widodo. In order to achieve the target, the Government needs strategical thinking to identify the exact problem, what factors need to be considered, as well as factual solutions.
