"Similar to energy, without data center the spread of information will not be as cheap and fast as today. The larger investments on this sector, the cheaper it is for information distribution. Data center has now become the backbone of digital infrastructure that support economic growth," as Pandu explained.

However, he reminded that the main challenge does not only lie on investment and land procurement, but also on the readiness of the human resources.

"What needs to be promoted is not only the physical development of the data center, but also on the potential to attract global talents, allowing them to contribute in this ecosystem. If the appropriate ecosystem is created, data centers could become strong attracting power for Indonesian talents overseas to return home and work here, responding to trending hashtag of #KaburAjaDulu (Just Flee Already)

In line with the share thought, Andre Rahadian, Founding Partner Dentons HPRP, emphasized that data centers and AI are not only about technolpgy, but also about investment and Indonesia's human resources.

"If Indonesia wishes to be the center of digital economy, we must prepare competitive human resources. With a rapid GDP growth in the last few years, the competitiveness of our work force is lagging behind. This is now the time for our industry to take a more active role in creating supporting ecosystem that boost innovation and domestic job opportunities, one of which could be done by developing data centers," said Andre.

He also emphasized that without the proper and supporting regulation and poilicies, Indonesia is prone to high risk of losing the momentum in developing digital ecosystem that could retain and attract its best talents.
